### **Miley W. (Bucky) Glover, CPA, Re-Appointed to State Board of CPA Examiners**

Governor Bev Perdue has re-appointed Miley W. (Bucky) Glover, CPA, of Monroe, as a member of the State Board of Certified Public Accountant (CPA) Examiners. His term will expire June 30, 2015. Initially appointed to the Board in 2009, Glover is a member of the Board's Professional Standards Committee and is a former member of the Professional Education and Applications Committee.

The Board is an independent State agency that grants certificates of qualification as CPAs to those individuals who meet the legal requirements. The Board also adopts and enforces the rules of professional ethics and conduct to be observed by CPAs in North Carolina.

A past president and treasurer of the North Carolina Association of CPAs (NCACPA) and past member of the NCACPA's Board of Directors and Executive Committee, Glover received the *Raymond Rains Outstanding Service Award* from the NCACPA in recognition of his service to the CPA profession. He also received the NCACPA's *Visionary Award*.

Glover is a member of the American Institute of CPAs (AICPA) and has served as a member of the AICPA's governing council, as a member of the Governmental Audit Quality Committee, and as a member of a special AICPA task force to improve audit quality.

In addition, Glover is currently serving as the Middle Atlantic Regional Director of the National Association of State Boards of Accountancy (NASBA) is also the Chair of the of the State Board Relevance and Effectiveness Committee.

A graduate of the University of North Carolina at Charlotte and Chowan University in Murfreesboro, Glover was licensed as a North Carolina CPA in 1978. Glover began his accounting career at Arthur Andersen & Co. In 1979, he joined the firm Potter & Co., P.A., and became managing director of the firm in 1985.
