95 APPROVED AS CERTIFIED PUBLIC ACCOUNTANTS

Raleigh—On July 22, 2013, the North Carolina State Board of Certified Public Accountant Examiners approved 95 applicants for licensure as Certified Public Accountants (CPAs) in the State of North Carolina.

Applicants for licensure are required to pass the Uniform CPA Examination and satisfy the education, work experience, and moral character requirements of the Board. A CPA certified to practice in North Carolina must annually renew his or her license and complete at least 40 hours of Continuing Professional Education (CPE), including an ethics course. North Carolina has more than 19,000 actively licensed CPAs.

Established in 1913 by Chapter 93 of the North Carolina General Statutes, the State Board of CPA Examiners is an occupational licensing board that grants certificates of qualification as CPAs to those individuals who meet the statutory requirements. The Board also adopts and enforces the rules of professional ethics and conduct to be observed by CPAs in North Carolina. There are about 19,500 actively licensed North Carolina CPAs.
