52 APPROVED AS CERTIFIED PUBLIC ACCOUNTANTS

RALEIGH - On March 18, 2015, the North Carolina State Board of Certified Public Accountant (CPA) Examiners approved 52 applicants for licensure as Certified Public Accountants (CPAs) in the State of North Carolina.

Applicants for CPA licensure are required to pass the Uniform CPA Examination and satisfy the education, work experience, and moral character requirements of the Board. A CPA licensed to practice in North Carolina must complete at least 40 hours of Continuing Professional Education (CPE), including two hours of ethics education, each year to be eligible for renewal of his or her license and. North Carolina has more than 20,000 actively licensed CPAs.

Established by Chapter 93 of the North Carolina General Statutes (NCGS), the State Board of CPA Examiners is the occupational licensing board that grants certificates of qualification as CPAs to those individuals who meet the statutory requirements. The Board also adopts and enforces the rules of professional ethics and conduct to be observed by CPAs in North Carolina. In accordance with NCGS 93B-3, the State Board of CPA Examiners has made the public record portions of its database available through its website, www.nccpaboard.gov.
