### **85 NORTH CAROLINA CANDIDATES PASS UNIFORM CPA EXAMINATION**

**Raleigh, North Carolina**—The North Carolina State Board of Certified Public Accountant (CPA) Examiners is pleased to announce that 85 North Carolina candidates successfully completed the Uniform CPA Examination during the January-March 2015 testing window.

The Uniform CPA Examination consists of four sections: Auditing and Attestation (AUD), Business Environment and Concepts (BEC), Financial Accounting and Reporting (FAR), and Regulation (REG). These four sections represent a total of 14 hours of testing. The purpose of the Uniform CPA Examination is to provide assurance that those individuals who pass the CPA Examination possess the level of technical knowledge and the skills necessary for initial CPA licensure in protection of the public interest.

The successful Uniform CPA Examination candidates must now meet the education, work experience, and moral character requirements of the Board to become licensed as CPAs in the State of North Carolina.

*Established by Chapter 93 of the North Carolina General Statutes, the State Board of CPA Examiners is an occupational licensing board that grants certificates of qualification as CPAs to those individuals who meet the statutory requirements. The Board also adopts and enforces the rules of professional ethics and conduct to be observed by CPAs in North Carolina. North Carolina has more than 20,000 CPAs with active licenses.*
