147 NORTH CAROLINA CANDIDATES PASS UNIFORM CPA EXAMINATION

Raleigh, North Carolina—The North Carolina State Board of Certified Public Accountant (CPA) Examiners is pleased to announce that 147 North Carolina candidates passed the Uniform CPA Examination (Exam) in the October-December 2017 testing window. In calendar year 2017, 613 North Carolina candidates passed the Exam.

The Uniform CPA Examination consists of four sections: Auditing and Attestation (AUD), Business Environment and Concepts (BEC), Financial Accounting and Reporting (FAR), and Regulation (REG). These four sections represent a total of 16 hours of testing. The purpose of the Uniform CPA Examination is to provide assurance that those individuals who pass the CPA Examination possess the level of technical knowledge and the skills necessary for initial licensure in protection of the public interest. The candidates must now meet the education, work experience, and moral character requirements of the Board to become licensed as CPAs in the State of North Carolina.

About the Board

Established by Chapter 93 of the North Carolina General Statutes, the State Board of CPA Examiners is an occupational licensing board that grants certificates of qualification as CPAs to those individuals who meet the statutory requirements. The Board also adopts and enforces the rules of professional ethics and conduct to be observed by CPAs in North Carolina. An independent State agency, the Board is composed of seven members appointed by the Governor. Five members must be holders of valid and unrevoked NC CPA certificates as issued by the Board in accordance with the NC General Statutes. The remaining two members, who are not CPAs, represent the interests of the public-at-large. North Carolina has more than 21,400 CPAs with active licenses.
