We request that you mark each document with "Exhibit," the letter "R," the document number, and the page number for each page of the document. Example: "Exhibit-R-1-3," which would indicate that the document is Respondent's exhibit number 1, page number 3. Of course, both Board staff and you may offer additional exhibits into evidence at the hearing. You would need to bring sixteen (16) copies of each document not previously distributed to the Board members that you plan to enter into evidence at the hearing and mark each document as noted above.
