Example: "Exhibit-R-1-3" which would indicate that the document is Respondent's exhibit number 1, page number 3. Of course, both Board staff and you may offer additional exhibits into evidence at the hearing. You would need to bring sixteen (16) copies of each document, not previously distributed to the Board members, which you plan to enter into evidence at the hearing and mark each document as noted above. If you choose not to have documents distributed to the Board prior to the hearing, please provide at least

one (1) copy of documents that you anticipate presenting to the Board at the hearing, which must be received by the Board office on or before 5:00 p.m. on June 29, 2020.
