STATE CPA BOARD APPROVES 117 INDIVIDUALS FOR NC LICENSURE

RALEIGH: The North Carolina State Board of Certified Public Accountant (CPA) Examiners is pleased to announce that it approved 117 individuals for CPA licensure on November 23, 2020. North Carolina has 22,131 CPAs with current licenses.

An applicant for licensure is required to pass the Uniform CPA Examination and satisfy the Board's education, work experience, and moral character requirements. CPAs licensed to practice in North Carolina must annually renew their license and complete at least 2,000 minutes (40 hours) of Continuing Professional Education (CPE) each year.

About the Board

Established by Chapter 93 of the North Carolina General Statutes, the State Board of CPA Examiners is an occupational licensing board that grants certificates of qualification as CPAs to those individuals who meet the statutory requirements. The Board also adopts and enforces the rules of professional ethics and conduct to be observed by CPAs in North Carolina. An independent State agency, the Board is composed of seven members appointed by the Governor. Five members must be holders of valid and unrevoked NC CPA certificates as issued by the Board in accordance with the NC General Statutes. The remaining two members, who are not CPAs, represent the interests of the public-at-large.
