Due to the hearing being conducted remotely, we would like to make sure that we have agreed upon, and distributed, all exhibits in time to mail them to the Board members so that they can look at the hard copies as the hearing proceeds. If you wish to have exhibits, please forward to the Board office a copy of those documents, on or before 5:00 p.m. on August 3, 2021. We request that you mark each document with "Exhibit," the letter "R," the document number, and the page number for each page of the document. Example: "Exhibit R-1-3," which
