NORTH CAROLINA CANDIDATES PASS UNIFORM CPA EXAMINATION

Raleigh—The North Carolina State Board of Certified Public Accountant (CPA) Examiners is pleased to announce that 45 North Carolina candidates passed the Uniform CPA Examination between June 1, 2022, and June 30, 2022.

The Uniform CPA Examination consists of four sections: Auditing and Attestation (AUD), Business Environment and Concepts (BEC), Financial Accounting and Reporting (FAR), and Regulation (REG). These four sections represent a total of 16 hours of testing. The Uniform CPA Examination assures that those who pass the CPA Examination have the technical knowledge and the skills necessary for CPA licensure. The successful Exam candidates must now meet the State's education, work experience, and moral character requirements to become licensed as North Carolina CPAs.

About the Board

The State Board of CPA Examiners is an occupational licensing board that grants certificates of qualification as CPAs to those individuals who meet the statutory requirements. The Board also adopts and enforces the rules of professional ethics and conduct to be observed by CPAs in North Carolina. The seven members of the Board are appointed by the Governor. Five members must hold valid and unrevoked NC CPA certificates issued by the Board under the NC General Statutes. The remaining two members, who are not CPAs, represent the interests of the public at large.
