## What Is an Administrative Forfeiture of a North Carolina CPA Certificate?

According to 21 NCAC 08I.0101(a), all active CPAs must renew their certificates annually by July 1. If a CPA fails to comply with the renewal requirement, the Board will send a demand letter to the CPA at their most recent mailing address, as per section (c) of the rule.

On July 1, 2024, the Board mailed demand letters to about 700 North Carolina CPAs who did not renew or request inactive status by the July 1 deadline.

The demand letter requires the certificate renewal to be completed within 30 days. The CPA also has the option to apply for inactive status, which

must be completed and submitted to the Board office within 30 days.

CPAs need a portal/dashboard account to renew their CPA certificate. The Board's homepage has a link for CPAs to create a user account for completing the annual renewal. Applications to request CPA-retired or inactive status are on the Forms & Applications page of the Board's website.

Administrative forfeiture of a North Carolina CPA certificate occurs when a CPA fails to renew or request a status change to inactive within the specified time frame. Consequently, the individual cannot use the CPA title in NC and must return their certificate to the Board office within 15 days of receiving the notice of forfeiture.

Although an administrative forfeiture is not a disciplinary action, using the CPA title while on forfeited status may result in disciplinary action by the Board. An individual whose certificate has been forfeited for failure to renew may apply for reissuance after meeting the 21 NCAC 08J .0106 requirements.

To avoid an administrative forfeiture, renew your certificate or request inactive status before August 1, 2024. If you have questions, please contact Buck Winslow, the Board's Licensing Manager.

#### **CPE Audit Orders**

The following matters are excerpted from Consent Orders issued by the Board in response to Continuing Professional Education (CPE) audit findings. Pursuant to NCGS 93-12(9), "any disciplinary action taken [by the Board] shall be in accordance with the provisions of Chapter 150B of the General Statutes. The clear proceeds of any civil penalty assessed under this section shall be remitted to the Civil Penalty and Forfeiture Fund in accordance with G.S. 115C-457.2." NCGS 115C-457.1(b) states, "The Fund shall be administered by the Office of State Budget and Management. The Fund and all interest accruing to the Fund shall be faithfully used exclusively for maintaining free public schools."

#### JASON BEHRENS, #40805 | LEBANON, NJ

The Board opened a case against Jason Behrens ("Respondent") for failure to complete the CPE required to renew their North Carolina CPA license.

As part of the CPE audit, the Board staff asked Respondent to provide certificates of completion for the 2021 and 2022 CPE years. The Board, in its review of the documents submitted by Respondent, determined that Respondent could not substantiate all of the CPE claimed for 2021.

Respondent's action is a violation of 21 NCAC 08N .0202(a), .0202(b)(3), and .0202(b)(4). Respondent's CPA certificate is

subject to a one-year stayed suspension starting the day the Respondent was granted inactive status.

If the Board finds that Respondent has violated any other Board Rules of Professional Conduct during the one-year period, the stay will be lifted, and Respondent's CPA certificate will be actively suspended.

Respondent may apply for active status of their CPA certificate by meeting the requirements of 21 NCAC 08J .0105(c) and paying a \$1,000 civil penalty.

#### CHRISTOPHER ALAN LAWING, #17039 | CONCORD, NC

The Board opened a case against Christopher Alan Lawing ("Respondent") for failure to complete the CPE required to renew their North Carolina CPA license.

As part of the CPE audit, the Board staff asked Respondent to provide certificates of completion for the 2021 and 2022 CPE years. The Board, in its review of the documents submitted by Respondent, determined that Respondent could not substantiate all of the CPE claimed for 2021 and 2022.

Respondent's action is a violation of 21 NCAC 08N .0202(a), .0202(b)(3), and .0202(b)(4). Respondent's CPA certificate is

subject to a one-year stayed suspension of the certificate starting the day it was placed on forfeit status.

If the Board finds that Respondent has violated any other Board Rules of Professional Conduct during the one-year period, the stay will be lifted, and Respondent's CPA certificate will be actively suspended.

Respondent may apply for reissuance of their CPA certificate by meeting the requirements of 21 NCAC 08J .0106, paying a \$1,000 civil penalty, and providing certificates of completion for CPE completed to make up for the prior deficiency.

#### REBECCA ROARK BOATWRIGHT, #26063 | BELMONT, NC

The Board opened a case against Rebecca Roark Boatwright ("Respondent") for failure to complete the CPE required to renew their North Carolina CPA license.

As part of the CPE audit, the Board staff asked Respondent to provide certificates of completion for the 2021 and 2022 CPE years. Respondent admitted to the Board they had not timely obtained the CPE required for renewal of their North Carolina CPA certificate.

The Respondent's action is a violation of 21 NCAC 08N .0202(a), .0202(b)(3), and .0202(b)(4).

Respondent's CPA certificate is subject to a one-year stayed suspension.

If the Board finds that Respondent has violated any other Board Rules of Professional Conduct during the one-year period, the stay will be lifted, and Respondent's CPA certificate will be actively suspended.

Respondent must pay a \$1,000 civil monetary penalty and make up the CPE shortfall.

July 31 Final Deadline: Individual CPA License Renewal for 2024-2025
